

**APPLICATION FOR CHARITABLE SOLICITATION  
CITY OF MARTIN, TENNESSEE**

**Martin Municipal Code, Title 9, Chapter 3, Sections 9-301 through 9-314**

9-301. **Permit required.** No person shall solicit contributions or anything else of value for any real or alleged charitable purpose within the municipality without a permit from the city recorder authorizing such solicitation. Provided, however, that this section shall not apply to any charitable organization operated exclusively among the members thereof, voluntarily and without remuneration for making such solicitations, or if the solicitations are in the form of collections or contributions at the regular assemblies of any such organization. (Ord. #8101, January 1981).

9-302. **Definitions.** (Can be reviewed at City Hall - Martin Municipal Code)

9-303. **Application for charitable solicitations permit.** An application for a permit to solicit as provided in 9-301 of this chapter, shall be made to the city recorder through a form provided by the City of Martin. Such application shall be sworn to and filed with the city recorder at least fourteen (14) days prior to the time at which the permit applied for shall become effective; provided; however, that the city recorder may, for good cause shown, allow the filing of an application less than fourteen (14) days prior to the effective date of the permit applied for. The application herein required shall contain the following information, or in lieu thereof , a detailed statement of the reason or reasons why such information cannot be furnished:
