Alderman Flatt made a motion to approve Ordinance 2021-02. Alderman Robbins seconded the motion.

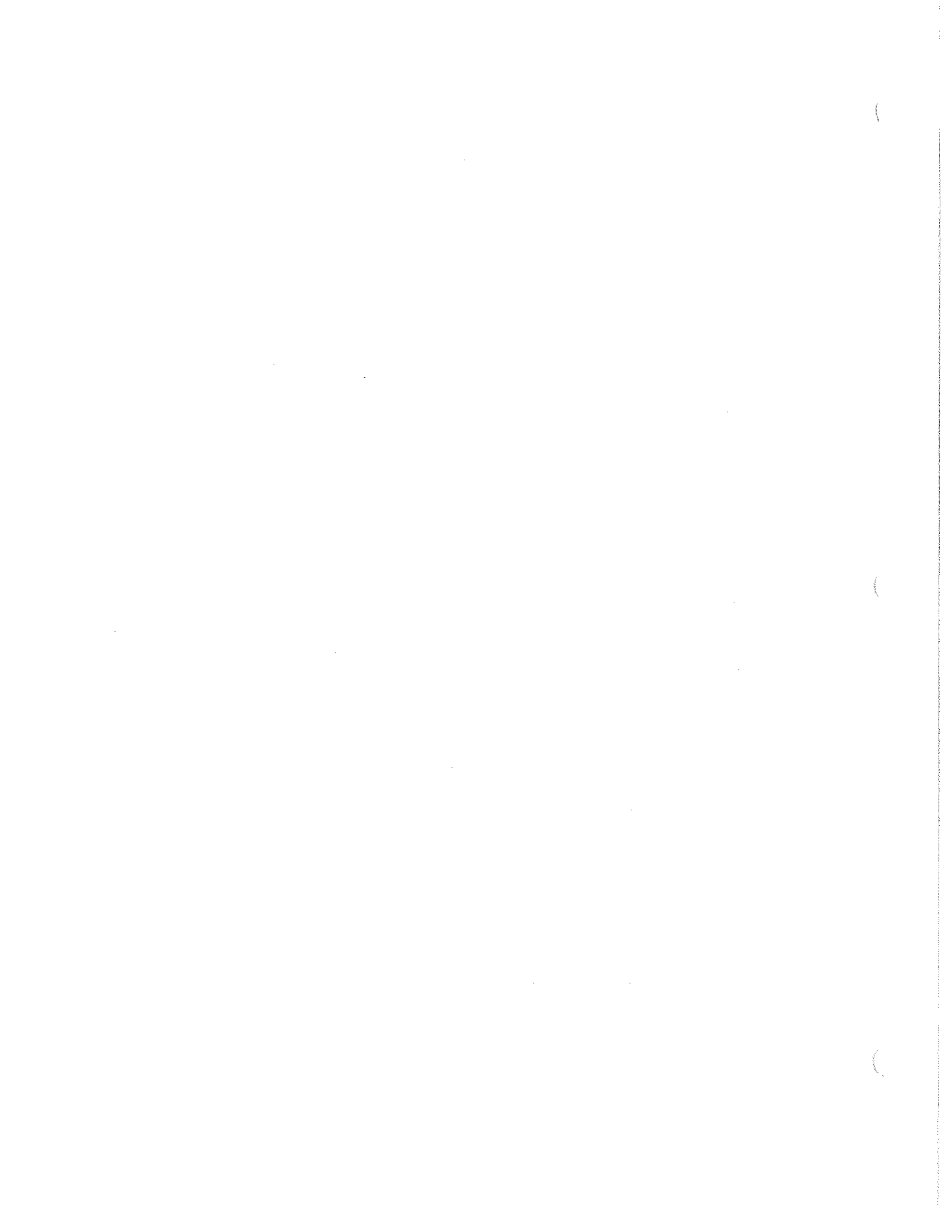
Mayor Brundige asked if there were any questions.

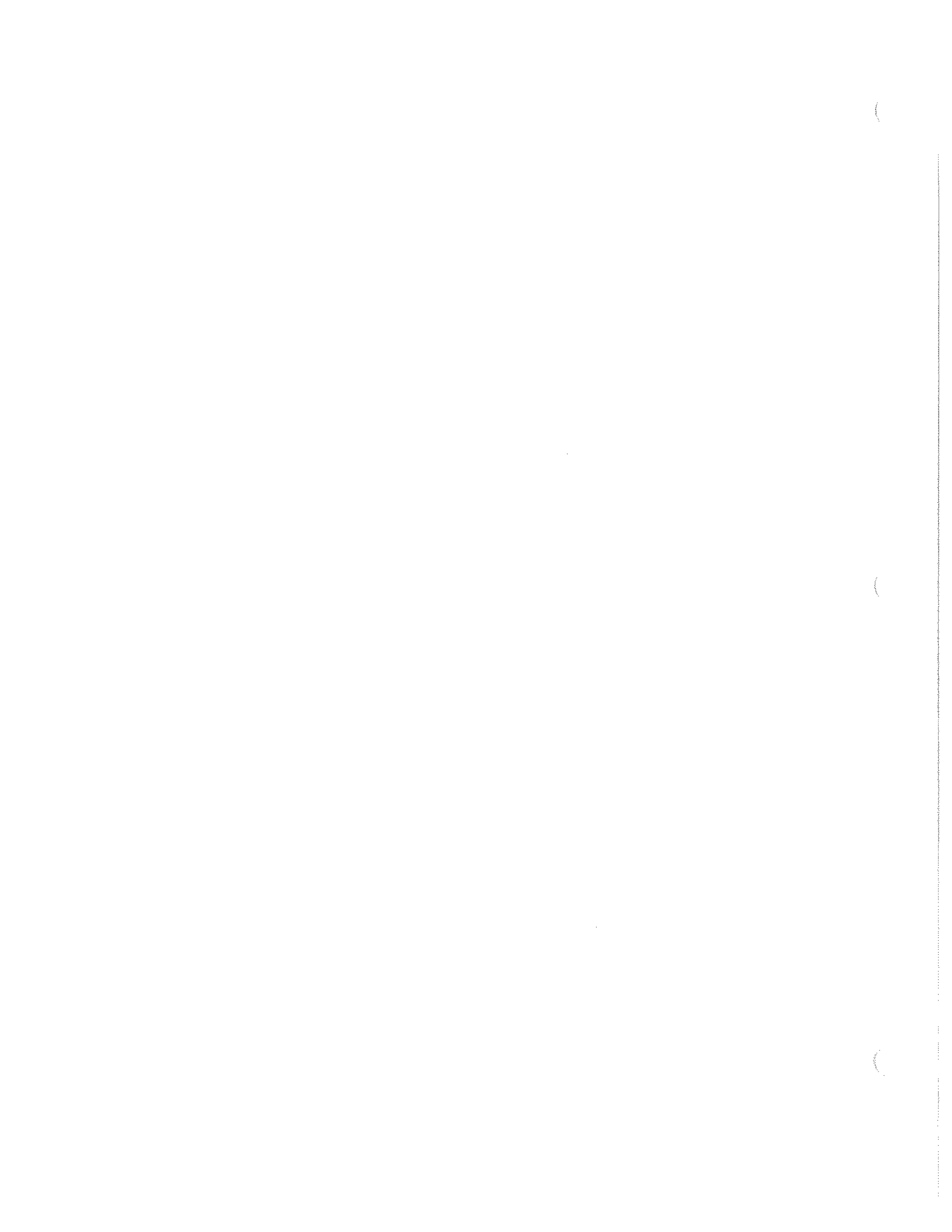



Alderman Nanney made the motion to adjourn, seconded by Alderman Hankins.


