## **NEW BUSINESS:**

### **THE CHARGER FOUNDATION - \$15,000.00 DONATION**

Mayor Brundige announced that The Charger Foundation has asked for a \$15,000.00 donation to help with school mascot changes and academics.

Mayor Brundige asked Mr. Tommy Legins if he would please explain a little more on the money use.

Mr. Legins announced that we have gone to the school board and presented the idea of all the schools to be as one (which is the Chargers) instead of having different mascots for each school. This has been passed so all of Martins schools are now The Chargers.

Mr. Legins commented that now that this has been accepted we want to change the whole brand which means things such as new sports uniforms and other types of brandings.

Mr. Legins said that we have faith that in around 12 months we can raise enough money to go forward with the academic side instead of only changing the brand, which is the ultimate goal of the foundation.

Alderman Pate asked in other ways do they plan to raise money for this foundation.

Mr. Legins responded saying we hope to go to local businesses and even parents. We have also had a lot of people offering their time and wanting to volunteer.

Alderman Nanney asked what changes will be made to help the academics.

Mr. Legins replied that we hope to apply this to more mentors, tutoring, and even small scholarships.

Alderman Nanney commented that Milan and Union City already have foundations such as this one. Have they been successful?

Mr. Legins replied saying yes their academics have increased.

Mrs. Elizabeth Pritchett spoke saying they are also looking into what is called mini grants. Teachers can apply to them for special projects or stem programs and also certain fields for technology use.

Alderman Belote asked if so much of this donation will go to academic ventures and so much goes toward the new branding.

Mr. Legins replied saying that we hope to have more fundraising events to help replace this donation and this be used towards more academics.

Alderman Belote commented that in his personal experience he would rather spend the money on buying his own uniform and seeing the money go towards academics.

Mr. Legins commented that we have had parents wanting to donate, that is why we think we can raise money for this academic cause.

Alderman Edwards made the motion to approve the donation of \$15,000.00 to The Charger Foundation and Alderman Belote seconded the motion.

Mayor Brundige made the suggestion to put this into a Resolution form and have the Resolution read at a special call meeting on the 19th.
